In late February, I received a call from an gentleman that needed help repairing damaged Vinyl Windows from a recent hail storm that caused major damage to an apartment complex he owned. I offered the job to my technicians Josh Funk and Kevin Heaton. I informed them that it would be a huge job. They accepted the offer and then scheduled a meeting with the owner. They traveled from Kansas City to Wichita to perform a show & tell demo because the owner of the building wanted to see if their work was good enough to pass a building inspection. The owner had mentioned that he was collecting from the insurance company for the hail damage and was already in the process of refinancing. He also had an estimate for replacing all the windows and it came in at \$500,000.00. Another concern for the owner was if he decided to replace the windows, it would have been a nightmare for the residents as the complex was fully occupied. When he saw what Dr. Vinyl could to do, he was very impressed and jumped at the opportunity to save nearly half a million dollars. Josh & Kevin completed the work in 8 working days (3 days the first two weeks and 2 days the third week). I'm really proud of Josh & Kevin for taking on this challenge. It couldn't have come at a better time for them considering this was right before the start of social distancing and when car dealers, restaurants and other businesses in our area began closing down due to Covid-19.

After the job was totally completed, below is the letter I received from the apartment complex owner where Josh & Kevin did the window repairs.

Hello All,

"Window repairs were completed today--results are great. Kevin and Josh from Dr. Vinyl did a fantastic job of matching color and completing repairs in a timely fashion. We had no concerns at all from residents and they were very mindful of the property.

As to be expected, there were some overages due to unseen damage during the count and additional ladder fees. Kevin alerted me to these additional fees as he came across them so I was fully informed during the process. Total invoice cost for all repairs came to \$52,755.00. I have attached the invoice for reference. I have also included the invoice from the initial test repair done in March totaling \$581.00."

I was a little doubtful about the quality of work I could do in this arena, but I sure didn't want to let those guys down. They had been such a big help to me in the past. I just had to say "Yes".

Little did I know how much of a gift was laid at my feet. Basically, Steve had done all the leg work making the contacts and finding out about the locations and their needs. All I had to do was take measurements, sew some covers, and install them on site. The only downside I can think of is that it was just terrible having to work inside an AIR CONDITIONED gym on a very hot June day! I was nervous at first because it was something new for me, as far as the gym work was concerned. I soon overcame that newness and basically fell in love with the work. I have just completed the first of four jobs. It was great. I can't believe I ever had any doubts about the job. Oh, I forgot to mention, the first job was over \$9,000.00! In reality it was as if Steve had called me up and just handed me that money.

Morale of the story: It is great when we in the Dr. Vinyl world can work together....and don't forget profitable.



The article & photo below was submitted by Will Faber, Dr. Vinyl of Central MO, showing a fabric repair on the 2012-2016 Chevrolet Equinox.

"I tried an experimental fabric repair on the mesh fabric found in 2012-2016 Chevy Equinox. The name of that fabric is called "**Plateau**" according to the Automotive Detroit Book. After my standard flocked velour repair was flush with the surface and dried medium hard, I used this flat-tipped engraving bit in my Dremel tool kit to make holes like the fabric design. I then touched them up with black dye. This was my first attempt. It was not perfect, but it looked really good. I was happy to have found this innovative solution for a challenging new fabric.

Thought I should share this with others! Does anyone have a better solution, besides to reupholster? Looking forward to seeing upcoming articles from other associates!"


